3 COMMENDING SHANON GARTH SNYDER ON ATTAINING THE RANK
4 OF EAGLE SCOUT IN THE BOY SCOUTS OF AMERICA.

6 WHEREAS, commendations and congratulations are
7 extended to Shanon Garth Snyder on attaining the rank of Eagle
8 Scout, the highest rank in the Boy Scouts of America; and

9 WHEREAS, the award will be presented to him in a
10 Court of Honor ceremony on March 28, 2010, at Church of the
11 Rock in Pascagoula, Mississippi; and

12 WHEREAS, the Eagle Scout Award, earned by only a
13 small percentage of Scouts, involves the completion of an
14 Eagle Project and represents many years of diligence in
15 pursuit of a worthy goal that brings honor to the Scout, his
16 family, and his troop; and

17 WHEREAS, a member of Boy Scout Troop 230, Shanon
18 Garth Snyder has progressed successfully through the levels of
19 Scouting since joining seven years ago, meeting the demanding
20 requirements for becoming an Eagle Scout while also fulfilling
21 many leadership roles including Chaplain's Aide, Patrol Leader
22 and Senior Patrol Leader, a position he held for several
23 terms; and

24 WHEREAS, in addition to completing an Eagle Project,
25 an Eagle Scout must earn at least 21 Merit Badges as evidence

1 of mastery in various Scouting skills, and must strive to
2 conduct himself with honor, loyalty, courage, cheer, and
3 service, the five integral responsibilities of a Scout; and

4 WHEREAS, Shanon Garth Snyder is also an outstanding
5 student who participates in extracurricular activities, and he
6 has contributed countless volunteer hours to worthy causes in
7 his community; his proud parents are Deirdre Snyder and Dane
8 S. Snyder; and

9 WHEREAS, through the years, Shanon Garth Snyder has
10 exhibited those hard-won characteristics of trustworthiness,
11 self-discipline, and good citizenship, all components of the
12 Scouting program; with the guidance and support of his
13 Scouting leaders, he has earned the esteem of his community,
14 fellow Scouts, and all Alabamians; now therefore,

15 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
16 HOUSES THEREOF CONCURRING, That in recognition of his
17 outstanding achievement in attaining the prestigious rank of
18 Eagle Scout, Shanon Garth Snyder is highly commended, and this
19 resolution is offered in tribute to him along with best wishes
20 in all future endeavors.
