3 MOURNING THE DEATH OF MR. JOHNNY DAVIS AND HONORING  
4 HIS LIFETIME OF ACCOMPLISHMENTS.

6 WHEREAS, it is with profound regret and sense of  
7 loss that we record the death and honor the life of a  
8 distinguished Alabama educator, Mr. Johnny Davis of Mobile;

10 WHEREAS, among his many accomplishments, Mr. Davis  
11 was inducted into the Stillman College Educator Hall of Fame  
12 in recognition of his excellence as a classroom teacher along  
13 with his service as chair of the Baker High School English  
14 Department for more than 16 years and writing curriculum and  
15 pacing guides for students and teachers of 11th Grade English  
16 in the Mobile Public School System; and

17 WHEREAS, in addition, he served as supervising  
18 teacher for student teachers from what was then Mobile College  
19 and from the University of South Alabama and has published  
20 work in professional magazines; his professional leadership  
21 roles include serving as president of the Escambia County  
22 Retired Teachers Association and president of the Alabama  
23 Retired Teachers Association; he served six years as a member  
24 of the National Education Resolutions Committee representing  
25 retirees from throughout the nation; and

1               WHEREAS, his academic credentials include graduating  
2       cum laude from Stillman College with a Bachelor's Degree in  
3       English and American History; he pursued postgraduate work at  
4       several universities and earned a Master's Degree in English  
5       Education and an Education Specialist Degree in Education  
6       Leadership; and

7               WHEREAS, he was the recipient of many honors and  
8       recognitions, including the NEA Retired Distinguished Service  
9       Award for 2006, and he was also named Teacher of the Year at  
10      the local and district levels; through the years, he earned  
11      widespread respect for his exceptional skills and tireless  
12      dedication; now therefore,

13              BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
14      HOUSES THEREOF CONCURRING, That the death of Mr. Johnny Davis  
15      is recorded with deep sadness, and this resolution is offered  
16      in highest tribute to his exemplary life of achievement and  
17      service, along with condolences to his family.
