6 highest commendation is extended to Lieutenant B. J.

22 and behavior; Lieutenant McCullough is also an excellent
23 motivational speaker, reaching more than 3,000 people each
24 year across the State of Alabama, including judges, teachers,
25 parents, and students; in his spare time, he is the director

1 of an Elmore County Juvenile Redirect Program, teaching and
2 directing teenagers to guide them back on the right track; and

3 WHEREAS, a devoted family man, he is married to the
4 former Cassandra Crosby and together they have three children
5 and two grandchildren; and

6 WHEREAS, Lieutenant McCullough's many professional
7 affiliations and community leadership roles include: Chair of
8 the Montgomery United Prevention System Council on Substance
9 Abuse, Board Member of SAYNO, Leadership Montgomery Class 24
10 and Alumni Committee, and member of Southern Pride Lodge 431;

12 WHEREAS, through the years, Lieutenant McCullough
13 has earned widespread respect for his exceptional abilities
14 and tireless commitment to his fellowman, most notably by
15 making a difference in the lives of troubled youth; his motto
