18 designed for men; she has mastered the skills of Practice of
19 Search and Rescue Operations in Forest Areas, Aerial Rescue,
20 Aquatic Rescue, and Emergency Techniques, among many others;

22 WHEREAS, Lieutenant Aline has held a number of
23 crucial positions with the Military Fire Department of Mato
24 Grosso, supervising, planning, and leading rescue operations

1 and teams; obtaining a specialty in Emergency and Disaster
2 Management has been a career-long dream of hers; and

3 WHEREAS, Lieutenant Aline has followed the example
4 of Captain Alessandro Soares' professional qualification
5 endeavor in the United States in furtherance of her
6 professional goal of helping the State of Mato Grosso to
7 improve its service capacity; Lieutenant Aline stands as a
8 living reflection of Captain Soares' gifts for leadership and
9 for inspiring international students; and

10 WHEREAS, the only female international student among
11 seven women in her Emergency Medical Program (EMP) course,
12 Lieutenant Aline is an outstanding student; she is an

15 States revere her record of outstanding achievement and
16 dedication; now therefore,
