3 MOURNING THE DEATH OF MR. CHARLES COOPER SULLIVAN.

5 WHEREAS, it is with profound sorrow and regret that
6 news is received of the death of Mr. Charles Cooper Sullivan
7 of Mobile, Alabama, on March 4, 2010; and

8 WHEREAS, the death of Mr. Sullivan leaves a great
9 void in the lives of his loving family, many friends, and the
10 entire community; and

11 WHEREAS, a native of Mt. Vernon, Alabama, and a
12 lifelong resident of Mobile, he was a proud veteran, having
13 served his country with honor and distinction in the United
14 States Air Force; Mr. Sullivan retired from the Postal Service
15 as a Postal Operations Specialist, Senior, after a 36-year
16 career; he was an active member of the Supervisor's Union,
17 serving as president and vice president; and

18 WHEREAS, Mr. Sullivan was tirelessly dedicated to
19 the Boy Scouts of America, where he served in many capacities,
20 earning both the Merit Award and the Silver Beaver, and
21 attending 30 consecutive summer camps; he was a Brotherhood
22 member of the Order of the Arrow; among his additional
23 community endeavors, Mr. Sullivan was a member and past
24 president of the Gulf Coast Opry and a member of the Mobile

1 Country Music Band; he was musically gifted and could play
2 every instrument; and

3 WHEREAS, a man of devout faith, Mr. Sullivan
4 formerly sang with the Graceful Trio of Grace United Methodist
5 Church and was an active member of New Hope United Methodist
6 Church, where he sang in the choir; and

7 WHEREAS, preceding him in death were his parents,
8 James C. Sullivan and Althea Sullivan; brothers, Lamar
9 Sullivan, William "Billy" Sullivan, and Cecil Sullivan;
10 sister, Dorothy Breland; and father-in-law, Fleetwood Bailey;
11 and

12 WHEREAS, he leaves to mourn his death his beloved
13 wife, Wanda B. Sullivan; son, John C. (Janeen) Sullivan; four
14 grandchildren, Jahrad C. Sullivan, Valarae B. Sullivan, Justin
15 Thornton, and Michael Thornton; sister, Lessie Todd;
16 mother-in-law, Muriel Bailey; brother-in-law and
17 sister-in-law, Bill and Judy Blitch; and a number of
18 additional caring relatives and friends; and

19 WHEREAS, Mr. Sullivan was a valued member of the
20 community whose presence will be greatly missed by those who
21 were privileged to know him; now therefore,

22 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
23 HOUSES THEREOF CONCURRING, That the death of Mr. Charles
24 Cooper Sullivan is recorded with deep sadness, and by copy of

1 this resolution, heartfelt sympathy is extended to his
2 grieving family.
