8 COMMENDING WILLIAM CECIL MARTIN, JR.: PROFESSIONAL  
9 ACHIEVEMENT.

11 WHEREAS, we note with great pride and appreciation  
12 the many personal and professional accomplishments of Mr.  
13 William Cecil "Bill" Martin, Jr.; and

14 WHEREAS, a native of Aliceville, Mr. Martin was the  
15 eldest of three sons born to Cecil and Mary Pyles Martin, who  
16 instilled a singular work ethic in him, as he was reared  
17 working for his mother at the Martin Inn in Aliceville; he  
18 continued to work throughout his high school career, until he  
19 graduated from Aliceville High School and entered the United  
20 States Army, serving with distinction for three years; and

21 WHEREAS, Mr. Martin married the late Alice Louise  
22 Barrett Martin, a union that produced three daughters, Rebecca  
23 Barrett, Mary Louise, and Alice Susan; following the 1947  
24 death of his father, Mr. Martin took over management of Martin  
25 Truck & Tractor Company, which has served the area since 1933;  
26 Mr. Martin has since married Mrs. Jean Jacobs Martin; and

1                   WHEREAS, Mr. Martin was a charter director of First  
2 National Bank of Aliceville and has served as Chair of the  
3 Board since its inception in 1965; under Mr. Martin's  
4 leadership the Bank has expanded many times, ultimately  
5 becoming First National Bank of Central Alabama, with assets  
6 of over \$250 million; and

7                   WHEREAS, Mr. Martin has been active in civic,  
8 professional, and philanthropic organizations too numerous to  
9 mention; he has served as National President of the North  
10 American Equipment Dealers Association, past president of the  
11 Alabama Equipment Dealers Association, Paul Harris Fellow with  
12 Rotary; past president of Pickens County Natural Gas,  
13 co-founder of Aliceville River Terminal, and as an Elder at  
14 First Presbyterian Church; and

15                  WHEREAS, we are honored by this opportunity to  
16 recognize the extraordinary service of Mr. Martin to his  
17 community, profession, and nation; now therefore,
