7 longtime, dedicated career of Alabama State Trooper Michael A.
8 Juran, who served for 25 years as a law enforcement officer
9 with the Department of Public Safety; and

10 WHEREAS, Trooper Juran began his career in August of
11 1986 as a Trooper Cadet in Morgan County, and shortly
12 thereafter was promoted to Trooper where he continued to serve
13 for nine years at the Decatur State Trooper Post; and

14 WHEREAS, in 1994, he was transferred to his home
15 county of Jefferson County where he served until 2005; during
16 his assignment to the Birmingham Post, Trooper Juran became a
17 member of the Department's Honor Guard Team, and also served
18 as a member of the Department's Special Operations; and

19 WHEREAS, in March of 2005, Trooper Juran was
20 promoted to the rank of Corporal and upon transfer, served at
21 the Tuscaloosa Post until his return to Jefferson County where
22 he served until his retirement in 2010; and

23 WHEREAS, during his career as an Alabama State
24 Trooper, he was honored to escort Coach Watson Brown and the
25 UAB Blazers Football Team, Governor Guy Hunt, members of the

1 Black Caucus, the Former United States Secretary of Labor
2 Elaine Chao, and numerous dignitaries throughout the state;

4 WHEREAS, Trooper Juran's honorable years of service
5 as a State Trooper were recognized by numerous awards
6 including the Good Samaritan Award and the Helping Heroes
7 Award; now therefore,

8 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
9 HOUSES THEREOF CONCURRING, That in recognition of outstanding
10 service as an Alabama State Trooper, highest commendations are
11 extended to Trooper Michael A. Juran, for whom a copy of this
12 resolution is provided with our sincere best wishes for all
13 future endeavors.
