2 ENROLLED, House Joint Resolution,

3 DESIGNATING THE SECTION OF ALABAMA HIGHWAY 17
4 BETWEEN COX CREEK PARKWAY AND THE ALABAMA-TENNESSEE STATE LINE
5 IN LAUDERDALE COUNTY THE MAJOR DAVID BLAIR FAULKNER MEMORIAL
6 HIGHWAY.

8 WHEREAS, the Alabama Legislature wishes to
9 commemorate the service and sacrifice of the late David Blair
10 Faulkner by naming a highway in his honor; and

11 WHEREAS, a native of Florence, Major Faulkner was
12 serving as an Active Guard and Reserve T-38 Instructor Pilot
13 for the 43rd Flying Training Squadron when his aircraft
14 crashed on landing at Columbus Air Force Base in Mississippi;
15 and

16 WHEREAS, Major Faulkner had earned numerous honors
17 for his service, including the Meritorious Service Medal,
18 Aerial Achievement Medal, Air Medal, National Defense Service
19 Medal, Armed Forces Expeditionary Medal, Global War on
20 Terrorism Service Medal; he had also been named an Air
21 Education and Training Command Distinguished Graduate and had
22 been awarded the Commander's Trophy; and

23 WHEREAS, Major Faulkner's sacrifice in service to
24 his country is a reminder of the debt of gratitude we owe to

1 the members of the United States Armed Forces for the courage
2 and valor they display every day; now therefore,

3 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
4 HOUSES THEREOF CONCURRING, That the section of Alabama Highway
5 17 between Cox Creek Parkway and the Alabama-Tennessee state
6 line in Lauderdale County is hereby designated the Major David
7 Blair Faulkner Memorial Highway and that the proper officials
8 are requested to place and maintain markers designating the
9 Major David Blair Faulkner Memorial Highway as provided in
10 this resolution.

11 BE IT FURTHER RESOLVED, That a copy of this
12 resolution be provided for presentation as a memento of this
13 honorary designation by the Alabama Legislature.
