8 MOURNING THE DEATH OF MRS. DORRY ANN HAYES JOHNSTON

11 WHEREAS, with profound sorrow and regret, we receive  
12 news of the death of Mrs. Dorry Ann Hayes Johnston Blackburn  
13 of Auburn, Alabama, on March 26, 2011, at the age of 80 years;  
14 and

15 WHEREAS, the passing of Mrs. Blackburn leaves a void  
16 in the lives of her loving family, her many friends, and the  
17 entire community, where she was well-known and highly  
18 regarded; and

19 WHEREAS, born September 12, 1930, in Birmingham, she  
20 was a 1948 graduate of Phillips High School, where she was  
21 named Miss Phillippian and received the DAR Good Citizenship  
22 Girl Award; as a student at Auburn University, she was chosen  
23 Sigma Chi Sweetheart and was named Miss Auburn; she pledged  
24 Alpha Gamma Delta Sorority and remained active throughout her  
25 life; and

26 WHEREAS, with her first husband, she established J  
27 and M Bookstore in 1953, an Auburn institution that is still

1 run by her sons; in addition, she was instrumental in founding  
2 the Auburn Beautification Council, which implemented the  
3 "Welcome to Auburn" signs and the "Tidy Tigers" Awards; and

4 WHEREAS, she was a faithful member of the Auburn  
5 United Methodist Church; among her many roles of community  
6 leadership, she was a member of the Green Gardeners, past  
7 president of the Auburn Women's Club, and a board member of  
8 the Auburn Cemetery Board; and

9 WHEREAS, preceding her in death were her father,  
10 Louie Winston Hayes; and her husbands, Walter George Johnston,  
11 Jr., and John Gilmer Blackburn; and

12 WHEREAS, she is survived by her beloved "Mama  
13 Gretel," wife of Louie Hayes, and their children, Lou Hayes  
14 and Nancy Hayes Smith; her three children, Walter George  
15 "Trey" Johnston, III, Dixie Johnston Fraley (Gray) Keller, and  
16 William Paul "Skip" (Glenda) Johnston; sister-in-law, Hazel  
17 Johnston Lee; and her grandchildren, Lauren Johnston,  
18 Elizabeth Johnston, (Paul) Johnson, Tracey Johnston, Hannah  
19 Johnston, Lydia Johnston, and Paul Johnston; she also is  
20 survived by the children and grandchildren of Gilmer  
21 Blackburn: Gay (Mark) Maloney and their children, Phyllis
