6 WHEREAS, with profound sorrow and regret, we receive
7 news of the death of Mrs. Dorry Ann Hayes Johnston Blackburn
8 of Auburn, Alabama, on March 26, 2011, at the age of 80 years;
9 and

10 WHEREAS, the passing of Mrs. Blackburn leaves a void
11 in the lives of her loving family, her many friends, and the
12 entire community, where she was well-known and highly
13 regarded; and

14 WHEREAS, born September 12, 1930, in Birmingham, she
15 was a 1948 graduate of Phillips High School, where she was
16 named Miss Phillippian and received the DAR Good Citizenship
17 Girl Award; as a student at Auburn University, she was chosen
18 Sigma Chi Sweetheart and was named Miss Auburn; she pledged
19 Alpha Gamma Delta Sorority and remained active throughout her
20 life; and

21 WHEREAS, with her first husband, she established J
22 and M Bookstore in 1953, an Auburn institution that is still
23 run by her sons; in addition, she was instrumental in founding
24 the Auburn Beautification Council, which implemented the
25 "Welcome to Auburn" signs and the "Tidy Tigers" Awards; and

1 WHEREAS, she was a faithful member of the Auburn
2 United Methodist Church; among her many roles of community
3 leadership, she was a member of the Green Gardeners, past
4 president of the Auburn Women's Club, and a board member of
5 the Auburn Cemetery Board; and

6 WHEREAS, preceding her in death were her father,
7 Louie Winston Hayes; and her husbands, Walter George Johnston,
8 Jr., and John Gilmer Blackburn; and

9 WHEREAS, she is survived by her beloved "Mama
10 Gretel," wife of Louie Hayes, and their children, Lou Hayes
11 and Nancy Hayes Smith; her three children, Walter George
12 "Trey" Johnston, III, Dixie Johnston Fraley (Gray) Keller, and
13 William Paul "Skip" (Glenda) Johnston; sister-in-law, Hazel
14 Johnston Lee; and her grandchildren, Lauren Johnston,
15 Elizabeth Johnston, (Paul) Johnson, Tracey Johnston, Hannah
16 Johnston, Lydia Johnston, and Paul Johnston; she also is
17 survived by the children and grandchildren of Gilmer
18 Blackburn: Gay (Mark) Maloney and their children, Phyllis
19 Maloney (Blake) Johnson, and Margaret Maloney; Lisa (Rob)
20 Ayerst and their children, Amanda (Frank) Jemison and Allison;
21 and Allison (Bobby) Akins and children, Anna and Lauren; and

22 WHEREAS, Mrs. Blackburn was a valued member of the
23 community; although her presence will be missed, her legacy
24 will endure and her memory will be cherished in the hearts and
25 minds of those who were fortunate to know her; now therefore,
