20 Principal of Homewood High School from 1988-1992; Principal of
21 Homewood High School from 1992-1998; and Director of Support
22 Services for the Homewood City School System from 1998-2011;

25 named Assistant Principal of the Year in 1990 and received the

1 University of Montevallo Lawrence B. Malone Outstanding
2 Principal Award in 1996; and

3 WHEREAS, Mr. Hathorne has been a leader in many
4 civic organizations including the Homewood Rotary Club; in
5 addition, he served on the Educational Scholarship Committee
6 at Dawson Memorial Baptist Church; and

7 WHEREAS, the contributions made by Mr. Hathorne are
8 immeasurable and far-reaching and, as a result of his service,
9 he has earned the admiration and respect of those persons who
10 have had the privilege of associating with him; now therefore,
