10 activities; and vice president for National Guard Affairs
11 AUSA, 3rd Region; and

12 WHEREAS, Mr. Carney has been recognized for his
13 service with numerous awards, including: Meritorious Service
14 Medal, U.S. Army; Humanitarian Medal, U. S. Army;
15 Distinguished Service Medal of Alabama; Spirit of America
16 Humanitarian Award; North Alabama Veterans Coalition Lifetime
17 Achievement Award; Presidential Gold Level Volunteer Service
18 Award; and Patriotism Award Region 3 from AUSA; and
