8 MOURNING THE DEATH OF MRS. JESSIE CAROLINE GREEN.

10 WHEREAS, with profound sorrow and regret, we receive
11 news of the death of Mrs. Jessie Caroline Green on February
12 16, 2011; and

13 WHEREAS, the passing of Mrs. Green leaves a void in
14 the lives of her loving family, her many friends, and the
15 entire community, where she was well-known and highly
16 regarded; she dedicated her entire life to the care and
17 service of others; and

18 WHEREAS, Mrs. Green was brought up by Ernest and
19 Jessie Horton Woods after the early death of her parents; she
20 faithfully attended Oak Grove United Methodist Church in the
21 Woodsbend community, and in later years she diligently served
22 St. Mary's United Methodist Church in many capacities; she was
23 a 1948 graduate of Cherokee County Training School and
24 possessed multiple skills; and

25 WHEREAS, Mrs. Green is fondly remembered by students
26 for her kindness and generosity as the Hatcher Elementary
27 School lunchroom overseer; in addition, she was one of the

1 first African-American women to integrate the Centre
2 Manufacturing Plant during the Civil Rights Movement in the
3 1960s; she later worked as a Certified Nursing Assistant and
4 was a private duty nurse for many years; Mrs. Green also loved
5 doing what she did best, cooking and helping others, with
6 Sageberry Catering; and

7 WHEREAS, she was an active and passionate member of
8 community and civic organizations such as the NAACP, the Civic
9 League, ADC, United Methodist Women, St. Mary's Kitchen
10 Committee Chairperson, and the Woodsbend Circle; she was also
11 a committed volunteer in other charitable causes including the
12 Helping Hands Organization, Spirit of Cherokee, Red Cross Soup
13 Supper, and Senior Circle; and

14 WHEREAS, preceding her in death were her husband,
15 Buster Marcus Cowser; parents, Jasper and Ellen Horton; and
16 sister, Sadie Horton; and

17 WHEREAS, she is survived by her children, Ester
18 Elaine Cowser Crawl-Bey, Harry Kent (Peggy) Cowser, and Carol
19 Green (Vincent) Oliphant; loving stepson, Thomas (Constance)
20 Woods; seven grandchildren, Timothy Gerard (Tamika) Crawl-Bey,
21 Brian Harris Cowser, Mohammed Hasan Crawl-Bey, Nadiyah
22 Crawl-Bey (Andre) Freeman, Shareef Abdul Ali Crawl-Bey, Clark
23 Vincent Oliphant, and Olivia Caroline Oliphant; six
24 great-grandchildren, Ayana Nicole Crawl-Bey, Emily Marie
25 Cowser, Myleyah Telaine Crawl-Bey, Jared Isaiah Crawl-Bey,

6 community; although her presence will be missed, her memory
7 will be cherished in the hearts and minds of those who were
