15 WHEREAS, Reverend Moore preached his first sermon at
16 the Second Baptist Church of Selma on the fourth Sunday in
17 January 1990; and

18 WHEREAS, born on June 22, 1966, he attended
19 Greensboro Public Schools in Greensboro, Alabama; he received
20 a Bachelor of Arts Degree in 1988 from Selma University and
21 earned 80 hours in the Juvenile Probation Officer Institute;

23 WHEREAS, Reverend Moore has worked with the Juvenile
24 Probation Office, in the Selma City School System, and
25 presently he is employed by the City of Selma in the Code
26 Enforcement Office; and

1 WHEREAS, in 1985, Reverend Moore pastored the Mt.
2 Horeb Baptist Church in Newbern, Alabama, before working with
3 the Pleasant Grove Baptist Church in Greensboro from
4 1988-1990, and the St. Matthew Baptist Church in Autaugaville
5 from 1987-1990; since 1990, he has been the pastor of the
6 Second Baptist Church in Selma; and

7 WHEREAS, the professional affiliations of Reverend
8 Moore include membership in the Selma and Dallas County
9 Ministerial Conference, the Selma University Alumni
10 Association, the Masonic Lodge 1674 in Greensboro, the
11 National Baptist Convention, the Alabama Missionary State
12 Convention, and he is Secretary of the New Shady Grove
13 District Association; and

14 WHEREAS, Reverend Moore has been listed in the
15 Outstanding Young Men of America and Who's Who Among American
16 College Students; he was given the Key to the City of Selma,
17 and was the recipient of the Best Pastor Award and nominee for
18 the Pastor of the Year; and

19 WHEREAS, Reverend Moore and his devoted wife, Irish,
20 are the proud parents of a son, Darrius, and daughter,
21 Irishia; and

22 WHEREAS the commitment, dedication, and Christian
23 guidance of Reverend Moore have earned for him the admiration
24 and respect of the members of the Second Baptist Church and
25 the entire community; now therefore,

26 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF
