13 selected to receive the 2011 Humanitarian Award of the Alabama
14 Library Association; and

15 WHEREAS, the award recognizes Mr. Onderdonk's
16 commitment to the growth and success of the Washington County
17 Public Library and his broader efforts to improve the quality
18 of life of many Alabamians through literacy and education; and

19 WHEREAS, an esteemed attorney and community leader,
20 Mr. Onderdonk is a 1967 graduate of The University of Alabama
21 School of Law; he has served on the Washington County Public
22 Library (WCPL) Board of Directors and Foundation Board for 23

25 more than \$450,000 for the library; and

27 libraries, literacy, and lifelong learning and helped to

2 decades ago; he has also worked diligently through the years
3 to write grants to improve library outreach services through
4 the Bookmobile and various reading programs in rural areas;

7 Representatives representing District 65, he held library
8 services as a high priority and was highly regarded for his
9 effectiveness and dedication; and

10 WHEREAS, among his awards and recognitions, he is a
11 past recipient of the Pillar of the Community Award and
12 Lifetime Achievement Award from the Town of Chatom, the Town
13 of Millry, Washington County Board of Education, Washington
14 County Department of Human Resources, and Washington County
15 Human Resources; and

16 WHEREAS, Mr. Onderdonk is a general bibliophile who
17 has enthusiastically supported the works of many local authors
18 and other southern writers; his unwavering commitment to
19 educational efforts, charitable organizations, and civic
20 groups has been an inspiration to many, and he is truly
21 deserving of this significant honor; now therefore,
