6 WHEREAS, it is with great pride and pleasure that we
7 commend David Carney for exemplary service and commitment to
8 the United States military, his country, and to his community;

10 WHEREAS, David Carney has endeavored to maintain the
11 tradition of commitment and service to his country by
12 graciously organizing a variety of events, both public and
13 private, to benefit the veterans and their families, as well
14 as other patriotic events; and

15 WHEREAS, having served eight years in the active
16 Army and 16 years with the National Guard, Mr. Carney's
17 commitment to the United States, or what he calls "the
18 greatest nation on earth" is unquestionable; among many
19 places, he has been deployed to Hungary, Croatia, Bosnia,
20 Kuwait, Japan, Thailand, Germany, and Italy; and

22 a master's degree in administrative science; he has worked as
23 a bank loan officer, is a published author, and has worked in
24 computer programming; and

1 WHEREAS, Mr. Carney has served in various leadership
2 positions including: Past president of the North Alabama
3 Veterans Coalition; past treasurer, Madison County Military
4 Heritage Commission; past commander, Legion of Honor, Cahaba
5 Shrine; vice president for National Guard Affairs for AUSA
6 Redstone, Huntsville; Chairman of the Awards Program for
7 Spirit of America; Operations Officer for Veterans Day
8 activities; and vice president for National Guard Affairs
9 AUSA, 3rd Region; and

10 WHEREAS, Mr. Carney has been recognized for his
11 service with numerous awards, including: Meritorious Service
12 Medal, U.S. Army; Humanitarian Medal, U. S. Army;
13 Distinguished Service Medal of Alabama; Spirit of America
14 Humanitarian Award; North Alabama Veterans Coalition Lifetime
15 Achievement Award; Presidential Gold Level Volunteer Service
16 Award; and Patriotism Award Region 3 from AUSA; and

17 WHEREAS, with a sense of pride and loving care, Mr.
18 Carney has been especially supportive in assisting with the
19 needs of returning veterans of all branches of the military
20 and in organizing patriotic events around the state; now
