3 COMMENDING PERRY WILBOURNE FOR PROFESSIONAL
4 ACHIEVEMENT.

6 WHEREAS, we take great pride and pleasure in
7 commending Perry Wilbourne of Foley, Alabama, for an
8 outstanding record of professional achievement on the occasion
9 of his retirement, which will be celebrated at a party in his
10 honor on April 29, 2011; and

11 WHEREAS, Mr. Wilbourne graduated from Marion
12 Military Institute and the University of Alabama; his service
13 in the United States Army included a deployment to Vietnam in
14 1965 where he received the Combat Infantryman's Badge; he
15 continued as an officer in the U.S. Army Reserve; and

16 WHEREAS, initially, Mr. Wilburne settled into the
17 family business, Wilbourne Implement Co. in Marion; he was
18 elected national president of the IH Farm Equipment Dealers
19 Association and served on the City of Marion Industrial Board;
20 in 1986, Mr. Wilbourne began working for the Perry County
21 Airport Authority and later became the City Administrator of
22 the City of Marion; and

23 WHEREAS, Mr. Wilbourne and his wife, Susan, have
24 three children, Sarah, Tom, and Wil and three grandchildren;

1 WHEREAS, in 1992, Mr. Wilbourne was hired as City
2 Administrator/Clerk for the City of Foley and he later became
3 a Certified Municipal Clerk; during his tenure with the City
4 of Foley there were multiple actions and accomplishments,
5 including the establishment of the Antique Rose Trail; and

6 WHEREAS, Mr. Wilbourne, an avid gardener and
7 fisherman, was the founder of the Antique Rose Trail, which
8 winds through downtown Foley offering over 500 different roses
9 with benches and gazebos along the way; the trail was
10 dedicated to Mr. Wilbourne on April 13, 2011; and

11 WHEREAS, after many years of devoted service, Perry
12 Wilbourne is retiring, leaving behind a legacy of kindness,
13 efficiency, and sincere devotion to the citizens of the City
14 of Foley; now therefore,

15 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
16 HOUSES THEREOF CONCURRING, That we are proud to commend Mr.
17 Perry Wilbourne for his professional achievement and
18 contributions to his community, and by copy of this resolution
19 we convey our highest esteem and best wishes for his
20 well-deserved retirement.
