12 School of Law, he was hired in 1974 as Staff Attorney for the  
13 ALM and in 1986 became the League's third executive director  
14 in its 75-year history; and

16 accomplishments, including financial enhancements for  
17 Alabama's municipalities through the oil and gas trust  
18 interest payments, passing of the revolving loan fund for  
19 wastewater improvement, and many additional significant state  
20 bills to support municipal revenue streams; and

22 Roquemore has been a protector of municipal rights, guarding  
23 Alabama's cities and towns against infringement of their  
24 authority through state and local legislation; and

1           WHEREAS, under his vision and leadership, the ALM's  
2 workforce has tripled in size to more than 60 skilled  
3 professionals, and the size of the headquarters has expanded  
4 proportionately to attend to the increasing responsibilities  
5 and programs that have empowered our municipalities to better  
6 serve the citizens of this great state; and

7           WHEREAS, through the years Mr. Roquemore has earned  
8 universal respect for his exceptional abilities and tireless  
9 dedication; he is truly a champion of municipal government,  
10 and always will be; now therefore,

11           BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
12 HOUSES THEREOF CONCURRING, That in recognition of his  
13 distinguished career with the Alabama League of  
14 Municipalities, Mr. Perry C. Roquemore, Jr., is honored and  
15 commended, and this resolution is offered in highest tribute  
16 and deepest appreciation to him as he begins his well-deserved  
17 retirement after 37 years of dedicated service to the State of  
18 Alabama.
