2 ENROLLED, House Joint Resolution,

3 EXPRESSING REGRET FOR THE STATE OF ALABAMA'S
4 INVOLVEMENT IN THE FAILURE TO PROSECUTE CRIMES COMMITTED
5 AGAINST RECY TAYLOR.

7 WHEREAS, on September 3, 1944, in the small Town of
8 Abbeville, Alabama, Recy Taylor, a young Black mother was
9 walking home from church with her companions when she was
10 confronted by a car of seven white men; the men forced Ms.
11 Taylor into the car at knife and gunpoint, drove off, and six
12 of the seven men brutally raped her in a deserted grove of
13 pine trees; and

14 WHEREAS, Taylor's younger brother, Robert Corbitt,
15 of Abbeville, said he remembers the day his sister was raped
16 67 years ago like it was yesterday, saying the police tried to
17 blame his sister, and the family was harassed so that he was
18 not allowed to play in the front yard; and

19 WHEREAS, an all white, all male grand jury failed to
20 bring any charges for indictment; and then Governor Chauncey
21 Sparks ordered a second investigation, and the grand jury
22 again failed to indict; and

23 WHEREAS, the case got the attention of NAACP
24 activist Rosa Parks, who interviewed Taylor in 1944 in
25 Abbeville and later recruited other activists to create the
26 "Alabama Committee for Equal Justice for Mrs. Recy Taylor";
27 and

1 WHEREAS, in an interview last year with the AP, Recy
2 Taylor, who now resides in Florida, said she eventually gave
3 up trying to bring charges against the men; and

4 WHEREAS, this deplorable lack of justice remains a
5 source of shame for all Alabamians; now therefore,

6 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
7 HOUSES THEREOF CONCURRING, That we acknowledge the lack of
8 prosecution for crimes committed against Recy Taylor by the
9 government of the State of Alabama, that we declare such
10 failure to act was, and is, morally abhorrent and repugnant,
11 and that we do hereby express profound regret for the role
12 played by the government of the State of Alabama in failing to
13 prosecute the crimes.

14 BE IT FURTHER RESOLVED, That we express our deepest
15 sympathies and solemn regrets to Recy Taylor and her family
16 and friends.

17 BE IT FURTHER RESOLVED, That it is the specific
18 intent of the Legislature that reparations shall not be
19 considered or made regarding past actions of the government of
20 the State of Alabama concerning the lack of prosecution of the
21 crimes committed against Recy Taylor, and that this resolution
22 shall not be used or construed in any manner whatsoever as
23 support for such reparations.
