23 Placement Program at Minor High School and is enrolled in four
24 AP courses; when his name was submitted to A+ College Ready,
25 he was chosen to be interviewed by Exxon Mobile and was
26 featured in a commercial regarding the National Math and

3 WHEREAS, Minor High School received the A+ College
4 Ready Grant in 2008-2009 and has increased its AP Course
5 offerings from three to eight classes and increased the number
6 of AP qualifying scores from one to 21; A+ College Ready was
7 created with a \$13.2 million, six-year grant from the National
8 Math and Science Initiative to establish an Advanced Placement
9 and Incentive Program in Alabama, for the purpose of
10 increasing the number of students enrolled in advanced courses
11 as well as increasing the number of students attending and
12 graduating from college with degrees in mathematics and
13 science; and

14 WHEREAS, Jelani Grace is an exceptionally
15 accomplished young man whose success reflects honor upon his
16 family, his school, and the entire State of Alabama, and he is
17 deserving of highest praise; now therefore,
