6 received of the death of Simon David Boozer of Anniston,  
7 Alabama, on April 11, 2011, at the age of 75 years; and

8 WHEREAS, Mr. Boozer was born to David Leon and Ruby  
9 Kyle Boozer, on January 12, 1936, in Anniston, Alabama; he  
10 graduated from Anniston High School and received a Bachelor of  
11 Architecture degree from Washington University of St. Louis,  
12 Missouri; and

13 WHEREAS, he served in the United States Army and  
14 Reserves prior to establishing his practice in Anniston as S.  
15 David Boozer, AIA Architect, PC; he retired in 1996 after 30  
16 years of practice; he was a member of the Alabama  
17 Architectural Foundation and the American Institute of  
18 Architects; and

19 WHEREAS, Mr. Boozer was a member of the First United  
20 Methodist Church of Anniston where he served on the Board of  
21 Stewards; he was a Master Mason, a member of the Scottish  
22 Rite, past president of the Anniston Rotary Club, long time  
23 board member of the Knox Concert Series, served on the  
24 Salvation Army Board and the YMCA Board; he was vice president  
25 of the Anniston Chamber of Commerce, a member of Leadership

1 Calhoun County, chair of Youth Leadership Calhoun County, and  
2 served in the International Executive Service Corps; and

3 WHEREAS, Mr. Boozer was preceded in death by his  
4 parents and his sister, Margaret van der Blom; he is survived  
5 by his wife, Patricia Foster Boozer; daughter, Margaret Ann  
6 Boozer-Strother; grandson, Kyle Misuel Boozer-Strother; son,  
7 David Edward (Leslie) Boozer; granddaughters, Lauren Elizabeth  
8 Boozer, Kaitlyn Alysa Boozer; Megan Christine Boozer;  
9 step-daughter, Kristi Michelle Key; stepson, Foster Douglas  
10 (Tina) Key; stepgrandsons, Trenton Foster Key, Austin Tyler  
11 Key, and Nicolas Colton Key; nephew, David Isbrand (Tanya)  
12 Vanderblom; nieces, Meg Dierke Vanderblom and Dina Wilhemina  
13 (Rickard) Birch; cousins, Emmet (Bobbie) Weaver and Alysa
