3 MOURNING THE DEATH OF MR. FRANK CAMPBELL.

5 WHEREAS, we note with great sadness the death of Mr.
6 Frank Campbell of Galant, Alabama, on Friday, April 29, 2011,
7 at the age of 86 years; and

8 WHEREAS, a lifelong resident of Gallant, he was born
9 on March 4, 1925, to the late Lula Hooks Campbell and James
10 Hale Campbell, and was married to the late Doris Norton
11 Campbell for 58 years; and

12 WHEREAS, he attended Etowah High School, Altoona
13 High School, and the University of Alabama, later serving in
14 the United States Navy during World War II; and

15 WHEREAS, June 15, 1949, Mr. Campbell was appointed
16 Postmaster of Gallant by Representative Albert Rains, and he
17 also served as city clerk, city carrier, and rural letter
18 carrier, retiring from the post office on April 12, 1988; and

19 WHEREAS, for over 30 years, he enjoyed delivering
20 flowers for Attalla Florist and he served for 17 years as
21 Political Action Committee Chairman for the Alabama Rural
22 Letter Carriers Association; and

23 WHEREAS, he was a member of Ivalee Baptist Church,
24 serving as deacon, and was a Mason from 1948 until his death,
25 receiving his 50-year Masonic pin; and

1 WHEREAS, in addition to his wife and parents, he was
2 preceded in death by his siblings, Willie Mac Campbell, Julius
3 Campbell, Ray Campbell, Veraline Campbell Howard, and Hubert
4 Campbell; and left to cherish his memory are his son, Benny
5 Campbell; his daughter, June Campbell Styles (Brent); his
6 granddaughter, Stacie Styles (W. Ken McCracken); his siblings,
7 Grady, Ralph, Frances, and Louie Campbell and Bill Hooks; his
8 sisters-in-law, Thelma Edgar, Carolyn Campbell, Juanita
9 Campbell, Elaine Campbell, Pinky Hooks, and Faye Campbell; his
10 brother-in-law, Raymond Howard; and numerous beloved nieces
11 and nephews; now therefore,

12 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
13 HOUSES THEREOF CONCURRING, That we regretfully mourn the death
14 of Mr. Frank Campbell and, by copy of this resolution, extend
