8 WHEREAS, we extend hearty congratulations to Mr.
9 Robert P. Denniston of Mobile, Alabama, who celebrates 70
10 years as an accomplished attorney on June 5, 2011; and

11 WHEREAS, born in LaPaz, Bolivia, on June 12, 1920,
12 Mr. Denniston graduated from the University of Alabama School
13 of Law in 1941 and was admitted to the Alabama State Bar that
14 same year on June 5; and

15 WHEREAS, Mr. Denniston attended the Hague Academy of
16 International Law, The Hague, Netherlands, and is a member of
17 the Farrah Order of Jurisprudence, the Alabama State Bar,
18 American Bar Association, and has served as President of the
19 Mobile Bar Association in 1964-1965, the Mobile County Chapter
20 of the Red Cross, and the Mobile Arts Council, as well as
21 numerous other civic organizations; and

22 WHEREAS, Mr. Denniston has served on several
23 committees of the Alabama Law Institute and is a member of the
24 Alabama Law Foundation and the American Bar Foundation; and

1 WHEREAS, Mr. Denniston's law practice is
2 concentrated in banking, business law, bankruptcy, real
3 estate, probate, and estate tax, and he has twice been awarded
4 the Alabama State Bar Certificate of Merit for service to the
5 legal profession; and

6 WHEREAS, in addition to his accomplished legal
7 career, Mr. Denniston served in the United States Navy
8 throughout World War II and for two years during the Korean
9 War, receiving thirteen campaign ribbons for his service, and
10 retiring with the rank of Commander; and

11 WHEREAS, Mr. Deniston enjoyed the distinction of
12 being aboard his father's yacht, "Sunshine," when it won the
13 silver cup for the St. Petersburg to Havana Race in 1931; and

14 WHEREAS, a prominent citizen of the Mobile
15 community, Mr. Denniston's 70th year as an accomplished
16 attorney is a landmark occasion which complements his military
17 and public service to this state; now therefore,

18 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
19 HOUSES THEREOF CONCURRING, That we are pleased to commend Mr.
20 Robert P. Denniston on the celebration of his 70th year as an
