7 gratefully accepted by fellow staff attorneys, as well as
8 those in the private sector; Karen's writing skills, both
9 technical and creative, are exceptional and her demanding

11 eminent authority on the Alabama Sunset Law and has ably
12 served as the Sunset Committee Attorney since 1994; her 12
13 years' tenure as the Attorney for the Senate Education
