7 the Daleville High School JROTC Rifle Team is congratulated  
8 for its accomplishments in marksmanship; and

9           WHEREAS, the team won the Wiregrass Rifle Conference  
10 Championship for the fourth straight year and also claimed the  
11 Army National JROTC Championship; and

12           WHEREAS, competing at the Interservice JROTC Air  
13 Rifle Championships where the top seven teams from the Army,  
14 Marines, Navy, and Air Force JROTC Units were represented,  
15 these exceptional cadets took second place, capturing the  
16 Silver Medal; and

17           WHEREAS, competing at the Army Marksmanship Unit  
18 Junior National Air Rifle Championships the team took first  
19 place and the Gold Medal, accomplishing its second national  
20 championship of the year; and

21           WHEREAS, at the NRA State Championships, the team  
22 again claimed victory, with Team #1 achieving the State  
23 Championship, and Team #2 achieving third place; and

24           WHEREAS, setting six individual national records in  
25 2011, team member Mikaelah Atchley earned three Gold Medals,

1       one at the Interservice Air Rifle Championships, one at the  
2       Army Marksmanship Unit Junior National Air Rifle  
3       Championships, and again at the NRA State Championships; and

4               WHEREAS, exceptional leadership was provided by LTC  
5       (ret.) Ralph Aaron and CW4 (ret.) Joe Guthrie; and

6               WHEREAS, these fine young cadets indeed bring great  
7       honor to themselves, their school, and community and, along  
8       with their coaches, are deserving of highest praise for their  
9       dedicated efforts and accomplishments; now therefore,

10              BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
11       HOUSES THEREOF CONCURRING, That in recognition of outstanding  
12       achievement, the Daleville High School JROTC Rifle Team is  
13       most highly commended and congratulated for its
