6 WHEREAS, highest commendation is herein extended to
7 Dr. Celia Lloyd-Turney of Toney, Alabama, for her commitment
8 and service in the practice of medicine; and

9 WHEREAS, Dr. Lloyd-Turner, a native of Anguilla in
10 the Caribbean, grew up in St. Thomas and moved to the United
11 States in 1983; she earned a degree from Meharry Medical
12 College in Nashville and after her residency in Michigan
13 decided to move to Huntsville to be near her sister; and

14 WHEREAS, Dr. Lloyd-Turney met and married her
15 husband, Jessie Turney, and practiced medicine for 25 years at
16 Central North Alabama Health Care Services in Huntsville; and

17 WHEREAS, in 2007, Dr. Lloyd-Turney started a
18 nonprofit community clinic, Choice Medicine, to provide
19 general practice, pediatrics, gynecology, and dentistry to the
20 residents of northern Madison County; and

21 WHEREAS, Choice Medicine, became a family affair
22 with Dr. Lloyd-Turney's husband building the two-story clinic
23 and her son, Dr. Asher Turney, handling the workload until Dr.
24 Lloyd-Turney could wrap up her Huntsville practice; and

1 WHEREAS, Dr. Lloyd-Turney did not accept a salary at
2 Choice Medicine believing it to be her calling and mission to
3 serve others; Dr. Lloyd-Turney focuses on providing
4 personalized care for anyone who enters Choice Medicine
5 stating the clinic is "not for profit, but for care;" and

6 WHEREAS, Dr. Lloyd-Turney, who treats 50-60 patients
7 daily at Choice Medicine, is deserving of commendation and
8 appreciation for her invaluable contributions to the
9 community; she is deeply committed to her mission of providing
10 service, assistance, and medical care to others; now
11 therefore,

12 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
13 HOUSES THEREOF CONCURRING, That highest commendations are
14 extended to Dr. Celia Lloyd-Turney and her work at Choice
