2 Elmer and Lula Mae Tucker, and sisters, Dorothy Thommason and
3 Sarilyn Brodnax; and

4 WHEREAS, he is survived by his beloved wife of 43
5 years, Dottie Ann Oliver Tucker; son, Stephen Paul Tucker;
6 brothers, Bennie (Naomi) Tucker, Leland (Linda) Tucker, and
7 Dewey (Linda) Tucker; sisters, Betty Thommason, Carolyn
8 (Charles) Trundle, and Patsy Morris; brothers-in-law, Jimmy
9 (Judy) Oliver and Jerry (Barbara) Hall; sisters-in-law,
