9     activities and contributes to the betterment of his community  
10    through volunteering in worthy causes; he is the son of Ward

12          WHEREAS, Bryant C. Cheatham is an exceptional young  
13    Alabamian who has indeed exemplified Scouting's admirable  
14    attributes of self-discipline, self-reliance, good  
15    citizenship, devotion to duty, and concern for his fellowman;

17    and his community, and he is truly deserving of this
