9 INTO THE HALL OF FAME OF THE ALABAMA MANUFACTURED HOUSING

12 WHEREAS, commendations and congratulations are  
13 herein extended to Mr. Stephen J. Logan on the occasion of his  
14 induction into the Hall of Fame of the Alabama Manufactured  
15 Housing Association (AMHA); and

16 WHEREAS, nominees are selected for their outstanding  
17 contributions to the manufactured housing industry, along with  
18 dedicated service to the community; and

19 WHEREAS, born and reared in Haleyville, Alabama, Mr.  
20 Logan earned a Bachelor's Degree in Education from the  
21 University of North Alabama and was a football standout for  
22 the Lions for four years; he taught and coached for one  
23 semester at Muscle Shoals High School and began working in  
24 sales in January 1965 for Frontier Homes in Haleyville, a  
25 division of Commodore Corporation of Omaha, Nebraska; in 1968,  
26 he joined Commodore Corporation in Red Bay, Alabama, as sales

1 manager until 1970, when he moved to Hamilton, Alabama, as  
2 sales manager and partner of Buccaneer Homes; and

3 WHEREAS, in 1981, he embarked upon a new venture by  
4 opening North River Homes, serving as president, and later  
5 served as president of Waverlee Homes in Hamilton before  
6 retiring; and

7 WHEREAS, Mr. Logan served in the Alabama Legislature  
8 from 1987-1991, representing Marion and Winston Counties, and  
9 was a member of the Banking, House Rules, and Agriculture and  
10 Wildlife Committees; he also received a United States Senate  
11 appointment to the National Manufactured Housing Commission,  
12 and he served as Mayor of Hamilton from 2000-2003; and

13 WHEREAS, he is a member of Hamilton First Baptist  
14 Church, past president of the Hamilton Kiwanis Club and also  
15 Kiwanis Lieutenant Governor, past president of the Marion  
16 County Cattleman's Association, affiliate president and  
17 lifetime member of the National Cutting Horse Association, and  
18 lifetime sponsor of Ducks Unlimited; he is married to Sherrian  
19 McDaniel Logan and is the father of three adult children, Joel  
20 (Lori) Logan, Molly (Joey) Aycock, and Lori (Will) Henson, and  
21 has six grandchildren; now therefore,

23 THE LEGISLATURE OF ALABAMA, That Mr. Stephen J. Logan is
