16 organizations including, currently serving as Vice President
17 of the Oxford Kiwanis Club, member of the Public Building
18 Authority for the City of Oxford; and serving as a board
19 member of the Calhoun County Easter Seals for over 25 years;

22 Miller has been a vital resource to many and her presence will
23 be greatly missed; a retirement reception honoring Mrs. Miller
