13 the Special Recognition Award of the Local Emergency Planning
14 Committee in 2004; and

15 WHEREAS, a founding member of the Huntsville-Madison
16 County 9-1-1 Center Board, he became Chairman of the Board of
17 Commissioners in 1993, played a major role in the 1997
18 construction of the 9-1-1 Complex, and has been instrumental
19 in maintaining the 9-1-1 Center as a world-class facility
20 through continuing technology upgrades; and

21 WHEREAS, in 2009, the Madison County Commission
22 acted to name the Huntsville-Madison County 9-1-1 Center in
23 honor of Harold H. Potts; and

24 WHEREAS, in 2011, Mr. Potts was appointed a lifetime
25 supernumerary nonvoting member of the Board of Commissioners

1 of the Madison County Communications District, where he had
2 served since its inception in 1986 and as Chairman of the
3 Board as of 1994; and

4 WHEREAS, Mr. Potts has made immeasurable
5 contributions to the well-being of the people of Madison
6 County, making the county a safer, healthier, and better place
7 in which to live; through the years, he has earned respect for
8 his exceptional abilities and tireless dedication, and he is
9 truly deserving of special recognition; now therefore,
