8 DESIGNATING THE AUBURN LABORATORY OF THE ALABAMA
9 DEPARTMENT OF FORENSIC SCIENCES THE F. TAYLOR NOGGLE, JR.,
10 LABORATORY.

12 WHEREAS, F. Taylor Noggle, Jr., was born August 17,
13 1945, in Augusta, Georgia. He attended public schools,
14 graduating from Louisville Academy High School in 1963. He
15 received his Bachelor of Science Degree in Chemistry from
16 Georgia Southern College in June of 1968. He received his
17 Master of Science Degree from Auburn University of Montgomery
18 in 1977.

19 WHEREAS, he began his career in Forensic Sciences
20 with the United States Army Criminal Investigation Laboratory
21 at Fort Gordon, Georgia, from February 1969 through November
22 1970 and was awarded the Army Commendation Medal for
23 Meritorious Service during this assignment.

24 WHEREAS, Mr. Noggle began employment with the
25 Alabama Department of Toxicology and Criminal Investigation on
26 January 6, 1971, later to be known as the Alabama Department
27 of Forensic Sciences. He held many positions while employed

1 with the department but worked primarily as a Drug Chemist.
2 During his career, he authored and co-authored approximately
3 90 articles in various scientific publications in conjunction
4 with the Auburn University School of Pharmacy. He also held
5 several administrative positions as Auburn Laboratory Director
6 and Drug Chemistry Coordinator and served as the statewide
7 Deputy Director until September 2002.

8 WHEREAS, on September 1, 2002, F. Taylor Noggle was
9 appointed as Interim Director of the Alabama Department of
10 Forensic Sciences and on December 17, 2002, he was appointed
11 permanent Director by Attorney General Bill Pryor until his
12 retirement on October 31, 2006.

13 WHEREAS, Mr. Noggle had many professional
14 affiliations and served as Vice President and President of the
15 Southern Association of Forensic Scientists.

16 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
17 HOUSES THEREOF CONCURRING, That the Auburn Laboratory of the
18 Alabama Department of Forensic Sciences shall be known as the
19 F. Taylor Noggle, Jr., Laboratory in honor of and in
20 appreciation for the distinguished service and leadership of
21 this outstanding individual.

22 BE IT FURTHER RESOLVED, That the appropriate
23 officials are requested to identify and display the newly
24 designated building in accordance with the provisions of this
25 resolution.
