7 position at Fort McClellan, Alabama; an excellent
8 entrepreneur, he has owned numerous businesses in Calhoun
9 County including Red Barron Taxi, Inc., a driver education
10 business, and laundromats; he also drove buses; he adhered to
11 and shared the belief, "You have got to go into something you
12 like, and don't go into anything you don't know something
13 about;" he touched many lives and left an inspiring legacy;
