10 WHEREAS, highest commendations and congratulations  
11 are herein proudly presented to General Dennis L. Via, who  
12 will become the 18th Commander of the United States Army  
13 Materiel Command (AMC), one of the largest Army commands with  
14 an impact in all 50 states and 144 countries; and

15 WHEREAS, General Via, who has the distinction of  
16 commanding at every level, previously served as the Deputy  
17 Commanding General and Chief of Staff of AMC; while serving in  
18 this capacity, he deployed to Southwest Asia in October 2011  
19 as the Commander, AMC Responsible Reset Task Force (R2TF) with  
20 the mission of leading the strategic integration of the Army  
21 Materiel Enterprise for the Retrograde of equipment and  
22 material from Iraq at the conclusion of Operation New Dawn

3 Command and General Staff College and the U.S. Army War  
4 College; and

5 WHEREAS, his command assignments include the 82nd  
6 Signal Battalion, 82nd Airborne Division; 3rd Signal Brigade,  
7 III Armored Corps; 5th Signal Command, U.S. Army Europe and  
8 7th Army, and the U.S. Army Communications-Electronics Life  
9 Cycle Management Command and Fort Monmouth, and his principal  
10 staff assignments include Division Chief, Joint Requirements  
11 Oversight Council (JROC), Office of the Deputy Chief of Staff,  
12 G-8, Headquarters, U.S. Army; Principal Director for  
13 Operations, Defense Information Systems Agency, and Deputy  
14 Commander, Joint Task Force-Global Network Operations, U.S.  
15 Strategic Command; and Director for Command, Control,  
16 Communications and Computer (C4) Systems, J-6, The Joint  
17 Staff; and

18 WHEREAS, General Via is married to the former Linda  
19 A. Brown of Warsaw, Virginia, and they have two sons, Brian, a  
20 third year student at the University of Virginia in  
21 Charlottesville, Virginia, and Bradley, a junior at Huntsville  
22 High School in Huntsville, Alabama; and

23 WHEREAS, through the years, General Via has earned  
24 profound respect for his exceptional abilities and unwavering  
25 commitment to the nation and to the defense of freedom and  
26 democracy; his achievements reflect immense honor upon the

1 State of Alabama and the United States, and he is truly  
2 deserving of special recognition; now therefore,
