6 of Cullman, Alabama, with deep sadness; his immeasurable life
7 of 90 years is celebrated and commended with thanksgiving; and

8 WHEREAS, the passing of Mr. Freeman leaves a void in

10 community, where he was highly regarded; and

11 WHEREAS, born June 3, 1922, in the Brushy Pond
