12 March 1, 2013, as Captain/Regional Commander, Drivers License
13 Division Region A, a position he had held for more than five
14 years, having been hired by the State of Alabama on January 4,

23 Corporal/Assistant Post Commander in May 1993 and
24 Sergeant/Post Commander in November 1997; and

26 Quad-Cities Highway Patrol Division and Assistant Platoon

1 Leader Special Operation Unit, and in January 2008, he was
2 elevated to the position of Captain/Regional Commander; and

3 WHEREAS, highlights of his distinguished career
4 include his election as Post Representative and Board Member
5 of the Alabama State Trooper Association and his contributions
6 to the establishment of a program through MADD to provide a
7 video camera for Quad-Cities Post Highway Patrol Division; and

8 WHEREAS, through the years and in all his endeavors,
9 he has earned respect for his exceptional abilities and
10 tireless dedication, and he is truly deserving of special
11 recognition; now therefore,
