19 develop Village Creek Human and Environmental Justice Society,

24 Director and Director of Finances of Village Creek Human and

3 WHEREAS, during his distinguished career, Mr.
4 Woodruff worked in a number of capacities for Alabama Power
5 Company including as Senior Engineer and Secretary of Alabama
6 Power Company Consulting Board for the Coosa River and Warrior
7 River hydroelectric developments; part of his work with
8 Alabama Power Company entailed planning, designing, operating,
9 maintaining, constructing, and reconstructing the company
10 Hydroelectric Dams; he has held esteemed positions with other
11 companies as well; and

12 WHEREAS, Mr. Woodruff received the Distinguished
13 Service Award 1999-2000 from Alabama Section, American Society
14 of Civil Engineers; and

15 WHEREAS, a native of Binghamton, New York, he was
16 born on March 22, 1913, and obtained a Bachelor of Science in
17 Civil Engineering from The University of Alabama in 1937; he
18 served as a Registered Land Surveyor in Alabama from 1948 to
19 1989 and has served as a Professional Registered Engineer in
20 Alabama since 1948; he was married to the late Gwendolyn R.
21 Woodruff for 59 years and has two sons, Michael and Richard L.
22 Woodruff; he is an active member of Independent Presbyterian
23 Church; and

24 WHEREAS, a 100th Birthday Celebration signifies a
25 century of memories and wisdom gained, and is a cause for

1 great rejoicing; it is a tremendous privilege to recognize Mr.
2 Woodruff on his special day; now therefore,
