8 MOURNING THE DEATH OF MR. EDWIN SILSBY HILL.

10 WHEREAS, we note the death of Mr. Edwin Silsby Hill
11 on March 23, 2013, with deep sadness; his immeasurable life is
12 celebrated and commended with great thanksgiving; and

13 WHEREAS, the passing of Mr. Hill leaves a void in
14 the lives of his loving family, many friends, and the entire
15 community, where he was highly regarded; and

16 WHEREAS, born July 27, 1933, in Darien, Georgia, he
17 was the son of William James and Edna Simington Hill, and he
18 graduated from St. Clair County Training School in Pell City,
19 Alabama, and received both his B.S. and M.S. Degrees and the
20 A.A. Certificate from Alabama A&M University, where he majored
21 in Administration and Supervision; he served with distinction
22 in the United States Army as a paratrooper and band member
23 with the 11th Airborne Division at Fort Campbell, Kentucky;

25 WHEREAS, Mr. Hill spent his entire life providing
26 leadership devoted to institutional change, promoting
27 opportunities for the economically disadvantaged, fighting

1 poverty, fostering human development, and participating in the
2 movement for a just society; as an educator, he aligned
3 himself with a number of groups committed to education
4 excellence and worked toward its attainment; he served as a
5 teacher at Council High School in Huntsville, as a principal
6 of both Toney Junior High School in Toney, Alabama, and
7 Tennessee Valley High in Hillsboro, Alabama, and as an adjunct
8 Assistant Professor of Sociology at the University of Alabama
9 in Huntsville; and

10 WHEREAS, Mr. Hill contributed expert guidance as a
11 public servant for over 33 years and cultivated an illustrious
12 career as the Chief Executive Officer of the Community Action
13 Agency Partnership, Inc., (CAAP) Huntsville, Madison, and
14 Limestone Counties, Inc.; his invaluable service extended to
15 the state level as a member of the Alabama A&M University
16 Board of Trustees and on the national level with the Selective
17 Service System; additionally, he served as President of
18 organizations including the North Huntsville Kiwanis Club,
19 Huntsville City Teacher's Association, Lawrence County
20 Teacher's Association, Lawrence County Principals'
21 Association, District I Alabama State Teacher's Association
22 and the Alabama Community Action Agencies Association; and

23 WHEREAS, Mr. Hill received numerous awards for his
24 magnanimous efforts; he was a charter member and ordained
25 Deacon/Elder in the Fellowship Presbyterian Church USA, a
26 charter member of the Huntsville Alumni Chapter of Kappa Alpha
27 Psi Fraternity, Inc., and a life member of the NAACP; and

1 WHEREAS, survivors include his beloved and devoted
2 wife, Zena L. Hill; daughter, Eddgra Fallin (Carl); niece,
3 Erica Burnette; sons, Edwin S. Hill, Jr. (Justine), Dwight
4 Hill (Mary), Veral Hill (Judith), and Franz Hill (Ellen);
5 step-sons, Frank Love (Cynthia) and Eric (Gaivanna) Love;
6 sister, Harriet (Charles Fluker) Knox; 13 grandchildren; 13
7 great-grandchildren; three step-grandchildren; sisters-in-law,
8 Gladys Jacobs, Alice Faye Brown (Willie Frank), and a host of
9 relatives and friends; he was preceded in death by his
10 parents; and brothers, William James Hill, Jr., and Samuel
11 Elisha Hill; and

12 WHEREAS, Mr. Hill was a valued member of the
13 community; although he will be greatly missed, his memory will
14 be cherished in the hearts and minds of those who were
15 fortunate enough to know him; now therefore,
