8 COMMENDING MOBILE POLICE OFFICER STEVEN CASERLO DION  
9 GREEN AS THE POSTHUMOUS RECIPIENT OF THE 2013 LEGISLATIVE  
10 MEDAL OF HONOR FOR LAW ENFORCEMENT.

12 WHEREAS, it is a great privilege to recognize Mobile  
13 Police Officer Steven Caserlo Dion Green as the posthumous  
14 recipient of the 2013 Alabama Legislative Medal of Honor for  
15 Law Enforcement, Alabama's highest law enforcement award for  
16 extraordinary courage in the line of duty; and

17 WHEREAS, born on February 25, 1975, Officer Green  
18 died on February 3, 2012, from a felonious assault while  
19 acting in his official capacity as a sworn law enforcement  
20 officer for the City of Mobile; the robbery suspect he had  
21 just transported to the Mobile Metro Jail produced a knife and  
22 stabbed Officer Green in the neck, a wound that proved fatal  
23 despite emergency medical care; the suspect subsequently  
24 engaged in a gunfight with other police officers and was shot  
25 and killed; and

26 WHEREAS, Officer Green was employed by the Mobile  
27 Police Department from May 22, 2010, until his death, earning

1       respect every day for his conscientious adherence to duty; he  
2       lived and died proving the inherent danger faced by our heroic  
3       law enforcement officers in their daily routines; and

4               WHEREAS, we are reminded of the scripture that there  
5       is no greater love than to lay down one's life for others;  
6       Officer Green made the ultimate sacrifice, and in so doing  
7       provided the State of Alabama with an enduring testament to  
8       the debt we owe to our valiant Law Enforcement personnel; and

9               WHEREAS, the life of Officer Green stands as a  
10       worthy exemplar of those caring and dedicated men and women  
11       who stand ever ready to serve and protect, and he is truly  
12       deserving of this significant honor; now therefore,

13              BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF  
14       THE LEGISLATURE OF ALABAMA, That we hereby recognize and most  
15       highly honor Mobile Police Officer Steven Caserlo Dion Green  
16       as the posthumous recipient of the 2013 Legislative Medal of  
17       Honor for Law Enforcement and direct that a copy of this  
18       resolution be provided to his family as evidence of our  
19       admiration and esteem.
