3 RECOGNIZING MAL MOORE ON HIS SERVICE TO THE  
4 UNIVERSITY OF ALABAMA.

6 WHEREAS, it is with highest respect that we  
7 recognize Mal Moore for his distinguished service to The  
8 University of Alabama; and

9 WHEREAS, Mr. Moore's association with the Crimson  
10 Tide began as a scholarship player for Coach Paul "Bear"  
11 Bryant in 1958 and spanned an amazing 53 years, including 22  
12 years as a coach before moving into administrative positions;  
13 he holds the distinction of being the only individual to be a  
14 part of eight National Championship teams at the University;  
15 and

16 WHEREAS, as a player and coach, he also contributed  
17 to 14 SEC Championships and 27 Bowl trips; and

18 WHEREAS, in addition to his tenure at Alabama, his  
19 31-year coaching career included stops at Montana State, Notre  
20 Dame, and the St. Louis/Phoenix Cardinals of the NFL; and

21 WHEREAS, after his coaching career, he became UA's  
22 Associate Athletic Director and then Director of Athletics in  
23 1999; Mr. Moore is credited with being instrumental in three  
24 national titles, football in 2009 and gymnastics in 2002 and  
25 2011, as well as numerous SEC championships in football,

1                   gymnastics, men's basketball, women's golf, men's golf, men's  
2                   cross country, baseball, and softball; and

3                   WHEREAS, Mal Moore built a department with a \$36  
4                   million annual budget into a \$101 million empire; he led a  
5                   building boom during a recession, twice expanding Bryant-Denny  
6                   Stadium and transforming the 74-year-old facility into a  
7                   101,821-seat state of the art facility, one of the jewels of  
8                   college football; and

9                   WHEREAS, through the years, Mal Moore's name has  
10                  become synonymous with the pursuit of excellence in athletics  
11                  at The University of Alabama; he earned respect for his  
12                  exceptional abilities and tireless dedication to team sports,  
13                  youth, and the State of Alabama, and his legacy will impact  
14                  generations to come; now therefore,

15                  BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
16                  HOUSES THEREOF CONCURRING, That it is a privilege to honor Mal  
17                  Moore for his service to The University of Alabama and college  
18                  sports, and this resolution is offered to his family in  
19                  admiration and appreciation for his service to the university.
