3           COMMENDING MOBILE POLICE OFFICER STEVEN CASERLO DION  
4 GREEN AS THE POSTHUMOUS RECIPIENT OF THE 2013 LEGISLATIVE  
5 MEDAL OF HONOR FOR LAW ENFORCEMENT.

7           WHEREAS, it is a great privilege to recognize Mobile  
8 Police Officer Steven Caserlo Dion Green as the posthumous  
9 recipient of the 2013 Alabama Legislative Medal of Honor for  
10 Law Enforcement, Alabama's highest law enforcement award for  
11 extraordinary courage in the line of duty; and

12           WHEREAS, born on February 25, 1975, Officer Green  
13 died on February 3, 2012, from a felonious assault while  
14 acting in his official capacity as a sworn law enforcement  
15 officer for the City of Mobile; the robbery suspect he had  
16 just transported to the Mobile Metro Jail produced a knife and  
17 stabbed Officer Green in the neck, a wound that proved fatal  
18 despite emergency medical care; the suspect subsequently  
19 engaged in a gunfight with other police officers and was shot  
20 and killed; and

21           WHEREAS, Officer Green was employed by the Mobile  
22 Police Department from May 22, 2010, until his death, earning  
23 respect every day for his conscientious adherence to duty; he  
24 lived and died proving the inherent danger faced by our heroic  
25 law enforcement officers in their daily routines; and

1           WHEREAS, we are reminded of the scripture that there  
2   is no greater love than to lay down one's life for others;  
3   Officer Green made the ultimate sacrifice, and in so doing  
4   provided the State of Alabama with an enduring testament to  
5   the debt we owe to our valiant Law Enforcement personnel; and

6           WHEREAS, the life of Officer Green stands as a  
7   worthy exemplar of those caring and dedicated men and women  
8   who stand ever ready to serve and protect, and he is truly  
9   deserving of this significant honor; now therefore,

10          BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
11   HOUSES THEREOF CONCURRING, That we hereby recognize and most  
12   highly honor Mobile Police Officer Steven Caserlo Dion Green  
13   as the posthumous recipient of the 2013 Legislative Medal of  
14   Honor for Law Enforcement and direct that a copy of this  
15   resolution be provided to his family as evidence of our  
16   admiration and esteem.
