18 as part of the Miss America preliminaries; and

21 earned her esteemed title and the honor to compete in the  
22 worthy program; and

23 WHEREAS, Miss Kinsey brings to the Miss America  
24 competition her noble platform, "Daring to Defeat Diabetes,"

26 on providing awareness and education regarding diabetes

1 through advocacy, public speaking, and promotion of ways to

13 research and the treatment of children affected by the  
14 disease; and

15                   WHEREAS, Miss Kinsey is combining her skills in  
16 public speaking and vocal performance to share her passion of  
17 being a champion in the fight to stop diabetes; and

18                   WHEREAS, Miss Kinsey's talents have shone in  
19 previous Miss Alabama Pageants while competing as Miss  
20 Birmingham, Miss Jefferson County's Outstanding Teen, and Miss  
21 Birmingham's Outstanding Teen; she placed in the top 11 and  
22 won talent and swimsuit preliminaries at Miss Alabama 2012;

24                   WHEREAS, as a standout student at The University of  
25 Alabama, Miss Kinsey has the distinction of being a  
26 Presidential Scholar, a Tutwiler Scholar, and Blount  
27 Undergraduate Initiative Student; and

2 the Miss Alabama Pageant awards college scholarships to  
3 extraordinary young women, fosters high achievement and  
4 involvement in the community and equips participants with  
5 valuable life tools; and

7 Kinsey is the daughter of Dr. Velda Pugh Kinsey and Robert O.  
8 Kinsey and the sister of Robert W. Kinsey; and

10 and displays the remarkable character and qualities espoused  
11 by the Miss America Organization; now therefore,
