3 AMENDING ACT 2012-123, HJR83 OF THE 2012 REGULAR  
4 SESSION, RELATING TO THE DESIGNATION OF A PORTION OF ALABAMA  
5 HIGHWAY 27 IN GENEVA SOUTHBOUND TO THE STATE OF FLORIDA  
6 BOUNDARY LINE AS THE SHERIFF LELON D. SIZEMORE OF GENEVA  
7 COUNTY MEMORIAL HIGHWAY.

9 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
10 HOUSES THEREOF CONCURRING, That the title and the second,  
11 third, fourth, fifth, and sixth paragraphs of Act 2012-123,  
12 HJR83 of the 2012 Regular Session are amended to read as  
13 follows:

14 "DESIGNATING A PORTION OF ALABAMA HIGHWAY 27 IN  
15 GENEVA SOUTHBOUND TO THE STATE OF FLORIDA BOUNDARY LINE AS THE  
16 SHERIFF L. D. "RED" SIZEMORE OF GENEVA COUNTY MEMORIAL  
17 HIGHWAY.

18 "WHEREAS, with highest tribute and deepest  
19 appreciation, the service of the late Sheriff L. D. "Red"  
20 Sizemore of Geneva County is herein recognized and honored;  
21 and

22 "WHEREAS, the life of Sheriff L. D. "Red" Sizemore  
23 was dedicated to the service and protection of his fellowman;  
24 there is no higher calling or greater sacrifice, and his

1 memory will be cherished in the hearts and minds of those who  
2 were fortunate to know him during his lifetime; now therefore,

3 "BE IT FURTHER RESOLVED, That, if possible, the  
4 signage should be designed and laid out in emblems and words  
5 as follows:

6 "Great Seal of the State of Alabama

7 "Sheriff L. D. "Red" Sizemore Memorial Highway.

8 "BE IT FURTHER RESOLVED, That a copy of this  
9 resolution be presented to the immediate family of Sheriff L.  
10 D. "Red" Sizemore, so that they may know of the esteem in  
11 which we hold their fallen family member and the service he  
12 made to his country, his state, and Geneva County."
