8 MOURNING THE DEATH OF MR. ALBERT WILLIAM THORNTON.

10 WHEREAS, we note the death of Mr. Albert William
11 Thornton on January 27, 2014, with deep sadness and regret;
12 his immeasurable life of 73 years is commended and celebrated
13 with great thanksgiving; and

14 WHEREAS, the passing of Mr. Thornton leaves a void
15 in the lives of his loving family, many friends, and the
16 entire community, where he was highly regarded; and

17 WHEREAS, born June 13, 1940, in the community of Mt.
18 Moriah in Coosa County, Alabama, he was the son of Albert
19 Ralph and Mary Lucille Thornton; he received his high school
20 education in Weogufka, Alabama, and entered Southern Union
21 State Community College in 1959, where he met and married
22 Sidiar Phillips from Langdale, Alabama; he graduated from
23 Auburn University in 1968; and

24 WHEREAS, upon graduation, he entered employment with
25 Wehadkee Yarn Mills in West Point, Georgia, where he retired
26 in 2006; he was a well-known and much sought-after Lay Speaker

1 in the East Alabama area for over 40 years, and he served as
2 interim pastor for many local churches; and

3 WHEREAS, Mr. Thornton was a former member of the
4 Alabama State National Guard; involved civically, he served as
5 President of the Neglected and Dependent Children and Youth
6 Council of Chambers County and also with Circle of Care for
7 Families of Chambers County, and as President of the Board of
8 Valley Haven School, which he served as a member for 20 years;
9 and

10 WHEREAS, a notable figure in the running community,
11 Mr. Thornton founded the Chattahoochee Chasers Running Club;
12 he, along with some fellow runners, organized the first Run
13 for Valley Haven School; he supported the school by running in
14 its Hike Bike Run Fundraiser for many years; it gave him
15 immense joy to be able to raise money for Valley Haven School
16 through running; "I have fought the good fight, I have
17 finished the race, I have kept the faith." 2 Timothy 4:7; and

18 WHEREAS, his meritorious public service ended when
19 he developed Alzheimer's disease in 2006; through the years,
20 Mr. Thornton earned immense respect for his tireless
21 dedication and exceptional abilities, and a spirit of
22 selflessness and giving were his magnanimous contributions in
23 this life; and

24 WHEREAS, Mr. Thornton was a valued member of the
25 community; although his presence is greatly missed, his memory
26 is cherished in the hearts and minds of all those who were
27 fortunate enough to know him; now therefore,

3 Mr. Albert William Thornton, we are immensely grateful for his
