12 Paragon's acquisition of high end wall decor, lighting and
13 accessory specialist, Kinder-Harris, to bring an added
14 dimension of exclusive hand painted art to the line and to
15 provide lamps and accessories to the market; and

18 Glassco, President; Malanta Glassco-Knowles, Vice President of
19 Marketing and Design; and Vince Glassco, Propac President; and
