11 Nesbitt of Gadsden, Alabama, on March 13, 2014; his
12 immeasurable life of 79 years is commended and celebrated with
13 great thanksgiving; and

14 WHEREAS, the passing of Mr. Nesbitt leaves a void in
15 the lives of his loving family, many friends, and the entire
16 community, where he was highly regarded; and

17 WHEREAS, born September 17, 1934, in Birmingham,
18 Alabama, he moved to Gadsden with his family in 1942 and
19 graduated from Gadsden High School in 1952; a 1956 graduate of
20 Auburn University, where he was a member of Kappa Sigma
21 Fraternity, he joined the family business, Nesbitt Motor Co.,
22 in Gadsden; and

23 WHEREAS, Mr. Nesbitt married Sonya Head Nesbitt in
24 1957 and remained in Gadsden as owner of Nesbitt Equipment
25 Company and later as a local businessman; he became a licensed
26 Methodist minister and local pastor; churches he faithfully
27 and devotedly served include Whorton Bend Methodist, Trinity

1 Methodist, Walnut Grove/Pine Grove Methodist and Valley Head
2 Methodist; he was very active in his church as a member of the
3 Martin Fellowship Class, Board of Stewards, and the choir; and

4 WHEREAS, civically minded, Mr. Nesbitt was involved
5 in a number of social organizations including the Intersae
6 Club, Serendipity, and Autumnal Club; and

7 WHEREAS, survivors include his beloved and devoted
8 wife, Sonya Head Nesbitt; children, Scott Nesbitt, Rebecca
9 (Ree) Nesbitt Mihelic (Matt), and Loren (David) Nesbitt
10 McGhinnas; grandchildren, Melinda (Jack) Mihelic Brock,
11 Matthew Mihelic, Kaydee Nesbitt, Michael Mihelic, Bro. Bernard
12 Johnathan Denson O.S.B., Taryn Nesbitt, Nathan Denson, Robert
13 Mihelic, Daniela Nesbitt, and Riley Nesbitt; sister, Harriett
14 Nesbitt Thompson; and brother-in-law, Quinn Head; he was
15 preceded in death by his parents, Walter P. Nesbitt and Marie
