2 ENROLLED, House Joint Resolution,  
3 DESIGNATING THE W. HARDY MCCOLLUM FLYOVER IN  
4 TUSCALOOSA COUNTY.

6 WHEREAS, the honorable W. Hardy McCollum is serving  
7 his sixth term of office and has continuously served as the  
8 Tuscaloosa County Judge of Probate and as Chair of the  
9 Tuscaloosa County Commission since 1977, a dual role in the  
10 largest county of this state where the judge of probate also  
11 serves as the chair of the county commission; and

12 WHEREAS, Judge McCollum, who served as President of  
13 the Association of County Commissions of Alabama in 1995-96,  
14 was a leader in the establishment of a statewide program of  
15 health insurance for county employees and he continues to be  
16 active on the ACCA Board of Directors and legislative  
17 committee; and

18 WHEREAS, Judge McCollum has also been active in the  
19 National Association of Counties, the Probate Judges  
20 Association of Alabama, and the National Association of  
21 Probate Judges; and

22 WHEREAS, Judge McCollum received the Association of  
23 County Commissions of Alabama 2011 Award for Outstanding  
24 Contribution to County Government; and

1               WHEREAS, the award was in recognition of Judge  
2 McCollum's significant contributions of time, talent, and  
3 energy to county government in this state; now therefore,

4               BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
5 HOUSES THEREOF CONCURRING, That the extension of M-Class  
6 Boulevard across United States Highway 11 and the Norfolk  
7 Southern Railroad to Tingle Tangle Road in Tuscaloosa County  
8 (ATRIP 63-05-36) be designated the W. Hardy McCollum Flyover  
9 and that the proper officials are requested to place and  
10 maintain markers designating W. Hardy McCollum Flyover as  
11 provided in this resolution.

12              BE IT FURTHER RESOLVED, That a copy of this  
13 resolution be provided to Judge McCollum as a memento of this  
14 honorary designation by the Alabama Legislature.
