10 WHEREAS, we note the death of Reverend Joseph Day, a
11 native of Dixons Mills, Alabama, on June 25, 2014, with deep
12 sadness and regret; his immeasurable life is commended and
13 celebrated with great thanksgiving; and

14 WHEREAS, the passing of Reverend Day leaves a void
15 in the lives of his loving family, many friends, and the
16 entire community, where he was highly regarded; and

17 WHEREAS, born May 8, 1928, he was the son of the
18 late Benny and Emma Grayson Day; and

19 WHEREAS, Reverend Day was a member of Greater
20 Morning Star Missionary Baptist Church in Mobile, Alabama, and
21 later became a member of Lizzie Chapel Baptist Church in
22 Macon, Georgia, after transferring to Warner Robins Air Force
23 Base in Warner Robins, Georgia; while there, he served as an
24 associate pastor; upon his return to Mobile, he reunited with
25 Greater Morning Star Baptist Church; and

1 WHEREAS, Reverend Day founded and organized the
2 House of Joshua Christian Center Church, where he served as
3 Senior Pastor until his passing; and

4 WHEREAS, survivors include six children, Melvia
5 Clemmons, Pastor Eric (Valerie) Day, Pastor Flora (Elder
6 Governor) Reiss, Phyllis Day, William Joseph Day, and Reverend
7 Wiley (Yolanda) Day; one brother, Edward Day; 19
8 grandchildren; 38 great-grandchildren including one very
9 devoted, Breanna Day; six great-great grandchildren; two
10 devoted god-daughters, Eugenia Thompson and Chanel (William)
11 Richardson; three devoted family members, Bobby Joe (Nora)
12 Grayson, Floretta Fortune, and Romaleen (Leo) James; one
13 devoted cousin, Delois Cannon; five special in-laws, Joan
14 (Sam) Yates, Dietra Beck, Dinisha Jackson, Anthony (Valerie)
15 James, and Gwendolyn James; a devoted caregiver, Lashunda
16 Washington; and a host of nieces, nephews, cousins, and
17 friends; he was preceded in death by his wife of 65 years,
