3                   RECOGNIZING THE COOSA-ALABAMA RIVER IMPROVEMENT  
4 ASSOCIATION, INC.

6                   WHEREAS, the Coosa-Alabama River Improvement  
7 Association, Inc., was founded in 1890 in Gadsden, Alabama, by  
8 a group of businessmen headed by William Patrick Lay to  
9 promote improvements in the Coosa River for the purpose of  
10 facilitating transport of goods between Gadsden and Rome,  
11 Georgia; and

12                   WHEREAS, the forward thinking of these businessmen  
13 set in motion the dream of harnessing the power of the Coosa  
14 River and connecting the Upper Coosa River Basin to the Port  
15 of Mobile via the Alabama River; and

16                   WHEREAS, the Coosa-Alabama River Improvement  
17 Association, Inc., was a driving force behind numerous  
18 improvements in the Alabama, Coosa, and Tallapoosa River  
19 Basins: The construction of federal and private hydropower  
20 facilities to generate sufficient electrical power for  
21 thousands of residences and businesses; the creation of  
22 reservoirs and lakes that provide recreation and economic  
23 benefits for the enjoyment of millions of outdoor enthusiasts;  
24 the construction of a nine-foot navigation channel in the  
25 Alabama River between Montgomery and Mobile; and

1           WHEREAS, the Coosa-Alabama River Improvement  
2 Association, Inc., was incorporated in 1955 in Montgomery,  
3 Alabama, under the leadership of Dr. Robert F. Henry, Sr., to  
4 promote continued development of the Alabama, Coosa, and  
5 Tallapoosa Rivers; and

6           WHEREAS, the Coosa-Alabama River Improvement  
7 Association, Inc., represents cities, counties, businesses,  
8 and private citizens addressing all issues pertaining to  
9 economic benefits and development of the Alabama, Coosa, and  
10 Tallapoosa River Basin; and

11           WHEREAS, the Coosa-Alabama River Improvement  
12 Association, Inc., has been, for 125 consecutive years, a  
13 primary advocate for economic development of the river basins  
14 in all aspects of navigation, recreation, hydropower, water  
15 supply, flood risk management, and environmental stewardship;  
16 now therefore,

17           BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
18 HOUSES THEREOF CONCURRING, That we recognize and honor the  
19 Coosa-Alabama River Improvement Association, Inc., for its 125  
20 years of service to the citizens of the Alabama-Coosa  
21 Tallapoosa River Basin, to the State of Alabama, and to the  
22 nation.

23           BE IT FURTHER RESOLVED, That an official copy of  
24 this resolution be prepared for the Coosa-Alabama River

1       Improvement Association, Inc., as an expression of our  
2       appreciation.
