8 COMMENDING ANDY FULLER UPON BEING INDUCTED INTO THE  
9 HUNTSVILLE-MADISON COUNTY ATHLETIC HALL OF FAME CLASS OF 2015.

11 WHEREAS, we take great pride and pleasure in  
12 recognizing Andy Fuller of Huntsville, Alabama, upon his  
13 induction into the Huntsville-Madison County Athletic Hall of  
14 Fame Class of 2015; and

15 WHEREAS, the son of Andrew and Dorothy Fuller, Andy  
16 Fuller acknowledges the support of his family and friends  
17 along his athletic journey; he is quick to name and thank  
18 special coaches and friends who have shaped his athletic  
19 career; and

20 WHEREAS, in high school, Fuller was a two-time  
21 All-City lineman in football and after graduating from J. O.  
22 Johnson High School, he signed with Auburn University; a  
23 four-year letterman at Auburn, he caught 22 passes for 573  
24 yards and five touchdowns; he was named to the All-SEC  
25 offensive team two consecutive years, won the Shug Jordan  
26 Award as the team's Outstanding Senior Player, was named "Top

1       Tiger" for his academic record, and participated in community  
2       service projects throughout his college years; and

3               WHEREAS, Fuller signed as a free agent with the  
4       Miami Dolphins; then while playing with the Barcelona Dragons  
5       of NFL Europe, he earned a World Bowl V championship ring in  
6       1997; after a year with the Regional Football League in  
7       Mobile, Fuller played five seasons with the Tennessee Valley  
8       Vipers of the Arena League, appearing in 73 games, catching 54  
9       passes for 573 yards and 28 touchdowns while also compiling 95  
10       tackles, 15 sacks, two interceptions, and five fumble  
11       recoveries on defense; and

12               WHEREAS, after serving as a graduate assistant at  
13       Alabama A and M University, Fuller became a full-time  
14       assistant on the staff and in 2014, he was named an assistant  
15       head coach; and

16               WHEREAS, Fuller, is married to Cynarra and together  
17       they have three daughters, Ashai Fuller, Ciedah Moore, and  
18       Chequata Moore; and

19               WHEREAS, exemplifying the qualities that sustain  
20       young athletes and inspire excellence in all sports, Andy  
21       Fuller is deserving of this special recognition; now  
22       therefore,

23               BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF  
24       THE LEGISLATURE OF ALABAMA, That it is a privilege to commend  
25       the accomplished athlete Andy Fuller on his well-deserved
